**AGENDA**

## **DISCUSSION ON RULE O20**

The Board received a letter from the Idaho Association of Chiropractor Physicians President Dr. Betz in support of the Board's efforts to clarify the chiropractic statute and administrative rules. Dr. Betz and Mr. Fitzgerald are willing to attend meetings and help in any way that is needed. Mr. Fitzgerald stated that it is a public safety issue and therefore, it would be the Board's purview to carry any legislative changes. Ms. Cory suggested that whoever carries the legislative changes could be decided later as work progresses on the changes. Mr. Smith stated that he helped the Midwives with their legislative changes and stated it is more important that the Board and Association and others that are involved are on the same page working toward the same goals, but some legislators feel scope of practice changes should come from the Association. Ms. Cory suggested that the Board use the full sub-committee that was appointed by the Board and add Mr. Fitzgerald. Mr. Coiner suggested adding legal counsel Mr. Ellsworth. It was suggested to review proposed legislation that a previous Chiropractor Board worked on in 2006 and see if the material could be used. Mr. Coiner made a motion to give Dr. Hollingsworth authority to add others to the sub-committee. Dr. Henze seconded the motion. Motion carried. The sub-committee will schedule meetings and bring a report to the next conference call meeting in two weeks.
