Dr. Henze moved to direct the Bureau to respond to Henry Schein pharmaceutical company that it is within the scope of practice as long as it is in accordance with Idaho Code 54-704(2)(b). Mr. Coiner seconded the motion. Motion carried.

SUBCOMMITTEE REPORT

Dr. Henze reported on the sub-committee that met May 27, 2014. Dr. Gartner-Ewing gave an overview of process the Board went through in 2006 through 2008 on the draft proposed laws and rules. The Board put a lot of work in meeting with the Board of Pharmacy, legislators, etc. and added a formulary council as part of the changes. The Board pulled the proposed draft law changes in January 4, 2008 because of lack of support from the Idaho Board of Medicine. Mr. Ellsworth reported that clinical nutritional methods were added in 1980 to the Board's law. The next sub-committee will meet June 10, 2014 at 2:30pm to move forward with working on draft law changes and invite Mark Johnson Idaho Board of Pharmacy. Dr. Hollingsworth asked Dr. Henze to thank Dr. Gaertner-Ewing for all the work and information she provided on the history of the draft proposed law changes.
