The meeting was called to order at 1:00 PM MST by Mary J White, DC.

APPROVAL OF MINUTES

The Board agreed to review the minutes from 10/1/2015 at the next meeting.

OLD BUSINESS

REVIEW LAW AND RULE TIMELINE

Ms. Cory reviewed the timeline of the law and rule changes. She said there were enough comments on the proposed rule to hold a hearing, which will be held on November 10, 2015. The Board has until November 27, 2015 to submit the pending rule for legislative review. The deadline to submit the final draft for legislation is December 4, 2015. Ms. Cory reviewed the process of the hearing.

NEW BUSINESS

DISCUSS PROPOSED RULE HEARING AND PROCESS

Mr. Hales also reviewed the hearing process with the Board. He let the Board know that the hearing officer will be Susan Buxton, and there will also be a court reporter to account for both oral and written comments. He said the hearing is pursuant to the

Administrative Procedures Act (APA), and only relates to Rule 020. He said a transcript of the hearing will be forwarded to the Board prior to its next meeting.

DISCUSS BOARD'S PROPOSED LEGISLATION

Mr. Hales reviewed the proposed law change and the letter that was sent by the Board to all licensees.

REVIEW REQUEST FROM THE IDAHO ASSOCIATION OF CHIROPRACTIC PHYSICIANS (IACP) TO PRESENT DRAFT LEGISLATION TO THE BOARD

Dr. White asked Ms. Cory to review the email received from Ryan Fitzgerald with the IACP. Ms. Cory said that Mr. Fitzgerald requested that the Board meet with some members of the IACP to review a "conceptual piece of legislation." The Board discussed the request and agreed that Mr. Fitzgerald should submit the proposed legislation or conceptual draft prior to the next meeting so the Board has time to review it. Mr. Coiner stated that the Board's role would be to give counsel on the legislation proposed by IACP; IACP would need to proceed with submission of the proposed legislation. Dr. Downey made a motion to invite Mr. Fitzgerald and IACP to the next meeting and ask that the Board be allowed to review the proposed legislation or concept prior to that date. It was seconded by Mr. Coiner. After further discussion, motion carried.
